- ⇒ The amount of the deposit should be remitted by an "Account Payee" cheque/draft payable at Vadodara and drawn in favour of "Transpek Industry Limited – Fixed Deposit Scheme".
- ⇒ The minimum amount of deposit acceptable under the non cumulative and cumulative schemes is Rs.10,000/- respectively for two years and three years. Any deposit in excess of the minimum acceptable amount covered under the above categories shall be in multiple of Rs.1,000/- only.

RENEWAL/REPAYMENT OF DEPOSITS:

- ⇒ The Company reserves the right not to repay a deposit before the date of maturity.
